ESSAY

Applicants for the named scholarships must answer any two of the questions below. For the grant applicants, please answer only one:

Fraternal Benefit Societies, like the AMLA, began in earnest more than 150 years ago. Most centered around key principals like self-reliance, respect for fellow members (regardless of social class), and preservation of society. In fact, fraternal societies were an affordable way to protect a family from the untimely death of the family's primary wage earner by providing necessary funds for a proper burial, child care for children, and financial aid to widowed spouses. Many fraternal benefit societies founded hospitals, orphanages, and general health care plans for members and friends throughout the early 1900's.

Over the ensuing decades, fraternal benefit societies

have been marginalized by government regulations, government assistance programs, and loss of market share to commercial entities. Today, the AMLA and other fraternal societies work to remain relevant to families through many of the same methods, but adapted for today's world:

- life insurance for all members which protects families financially from untimely death
- social and communal events that benefit members and their surrounding community
- self-reliance through programs like this one, which encourage all AMLA members to be successful in life.

The AMLA has continued to serve its members for more than 107 years! The common bond in 1910 was a Slovenian heritage. While this remains so, many members have joined from other cultural backgrounds.

Today, the AMLA is working to help members like you succeed in life. To the AMLA, you are more than just another life insurance policy.

Take some time to consider the following essay questions. Choose the one(s) you feel you would most like to answer, and share your thoughts with us!

- ESSAY 1: The AMLA was established in 1910, 107 years ago. Most people do not live that long, but where do you see yourself in 25 years? Include your career and family goals.
- ESSAY 2: The AMLA is an organization that is always striving to improve the lives of its members and build a stronger community. Describe a time when you performed a community service. Include how you feel it impacted the community. How did it impact you?
- ESSAY 3: The AMLA is an organization that is governed by its members. You, as a member in good standing with the AMLA, have a voice in our organization. How will you use your voice to improve the AMLA, your community, or your country?
- ESSAY 4: The AMLA is a fraternal benefit society which provides protection to its members through life insurance and fraternal benefits (like this scholarship and grant program). How would you describe the benefits of AMLA Membership to a friend.
- ESSAY 5: Your membership in the AMLA is not going to drastically change your life. The AMLA offers a benefit here and a benefit there to add up over your lifetime to a whole bunch of good. As an example of a small benefit, you can write about any topic you want. Be sure to describe why, out of all the infinite topics you could choose from, you chose the one that you did.

- 2a: Applicants seeking a scholarship must complete two (2) essay questions from the list. Answers must be at least 100 words, but not more than 500 words per essay.
- 2b: Applicants seeking a \$400 Grant must answer one (1) essay question from the list. Answers must be at least 100 words, but not more than 500 words per essay.
- 3: Applicants must attach transcripts from the last quarter, immediately prior to the quarter/semester to which the scholarship/grant will be applied.
- 4: Applicants must include a photograph of yourself that is at least 2"x 3" (jpg format preferred, send to Member@AmericanMutual.org, subject "AMLA Scholarship/Grant Program")
- 5: Read and sign the agreement below.
- 6: Send in the completed application and all necessary attachments in one package. E-mailed applications must have all attachments and enclosures in one email. SCHOLARSHIPS AND GRANTS OFFERED IN THIS PROGRAM

Anna Mae Mannion Scholarship - for first year college students. This \$2,000 scholarship is the name sake of one of the AM-LA's most devoted members. Anna Mae Mannion was Lodge President, and member of the AMLA's Board of Directors for more than 50 years. She was involved in many aspects of the Association.

Dr. Rudolph M. Susel Scholarship - for students who are already in college for at least one semester. This \$2,000 scholarship is the name sake of a the former AMLA *Our Voice* Editor and long-time AMLA Board Member. Dr. Susel was a professor at a prestigious university, and understood the value of a college education.

Joseph A. and Albina M. Abram Scholarship - for students who are already in college for at least one semester. This \$2,000 scholarship is the name sake of Joseph A. and Albina M. Abram, long-time AMLA Members who worked to further the benefits of AMLA Membership. The scholarship was established through the generosity of the Abram Family.

Frank J. Lausche Scholarship - for students seeking a graduate degree. This \$2,500 scholarship is funded by the Frances J. and Jane S. Lausche Foundation. Frank Lausche was an AMLA Member who was also Mayor of Cleveland, Ohio, Governor of the State of Ohio, and Senator representing Ohio. His foundation, named after his mother Frances, and wife Jane, is dedicated to preserving the Slovenian culture and community.

The AMLA Post-Secondary Educational Grant - This \$400 grant is awarded to up to 100 applicants according to the rules of the program.

RULES FOR AMLA 2017 POST-SECONDARY SCHOLARSHIP AND GRANT PROGRAM

- ➤ Must have been enrolled in AMLA prior to March 15, 2015, and currently in good standing (i.e. not on extended insurance).
- Must be enrolled or accepted as a full-time student at an accredited college or university, pursuing an associate, bachelor, or post–graduate degree
- Must have minimum of \$2,000 permanent life insurance (term insurance does <u>not</u> qualify).
- ➤ The program will award on a competitive basis one (1) Anna Mae Mannion Scholarship (\$2,000.00) to a first-year college student, one (1) Dr. Rudolph M. Susel Scholarship (\$2,000.00) to an advanced college student, one (1) Joseph A. and Albina M. Abram Scholarship (\$2,000.00) to an advanced college student, and one (1) Frank J. Lausche Scholarship (\$2,500.00) to a graduate student courtesy of the Frances and Jane S. Lausche Foundation
- Must complete the appropriate application form and return by the published deadline (postmarked by official deadline on application form).
- ➤ Recipients of the four (4) named competitive scholarships are not eligible to receive a grant in the same year.
- ➤ The program will award up to 100 post-secondary educational grants (\$400 each) selected by lottery.
- > Those applying for the Mannion, Susel, Abram, and Lausche Scholarships and not receiving them may reapply to be included in the lottery for the post-secondary grants.
- A member may receive a maximum of four (4) grants from the program over the course of their postsecondary education
- ➤ The Mannion, Susel, Abram, and Lausche scholarships will be sent directly to the college or university where the recipient is enrolled.
- Frant recipients will receive a letter informing them of their selection following an initial review of the applications submitted and the conducting of a lottery if necessary. Each recipient is required to be a full-time student in good academic standing at an accredited institution in pursuit of a degree. Enrollment as a full-time student for any period prior or subsequent to the grading period for the Fall 2017 academic year will not satisfy the eligibility requirement for payment of a grant. The information submitted will be reviewed for compliance with the standards of the institution attended prior to mailing of the grant payment. Non-compliance will result in forfeiture of the grant which will then be made available to the next alternate selected in the lottery previously conducted.
- Applicants enrolled as new members after January 1, 2005, must have one parent who is a member of AMLA under a permanent plan of insurance with a face value of at least \$1,000.00 issued prior to the deadline for submitting their request for a scholarship/grant application. This rule does not apply to all applicants who are members of AMLA as of January 1, 2005. After January 1, 2009, the minimum face amount of permanent insurance sold by AMLA is \$2,000.00. Any member who has an AMLA permanent insurance policy with a face value of at least \$5,000.00 is exempt from the parental membership requirement.
- Each of the Mannion, Susel, Abram, and Lausche Scholarships can be received one time only.
- Any applicant who has never been awarded a grant but has applied for a grant twice will automatically receive a grant on the third try, provided all other eligibility requirements are satisfied.
